### APPLICATION

For terraces, gravel or brick drives, driveways, house facades, walkways, roofs, fences and all external surfaces such as stone, wood, glass, concrete and ceramic surfaces, roof tiles and roofing felt, sidewalk paving, clinker and paving stones, terracotta etc.

### DIRECTION OF USE

Cut off the pouring spout with a sharp knife. The surface to be treated must be dry. Apply the Algae & Greenslime Remover generously and evenly. Wet the surface well and evenly. Do not rinse and allow to work-in for a minimum 24 hours. Residues will disappear without further treatment of the surface. Only in case of stubborn staining use a stiff brush or scrubbing tool, or allow to work-in for longer. If necessary, repeat the application. Clean working tools with water after use.

### IMPORTANT

Color changes (brown-red) may occur to the green residues during the working in period, which disappear again after the action of sun and weathering.
